ANTI-RAGGING COMMITTEE

POLICY ON ANTI-RAGGING

1. PURPOSE

Dr. L. D. Balkhonde College will strictly adhere to the provisions of The Maharashtra prohibition of Ragging Act of 1999, whereby ragging is considered as a criminal offence. As per the ruling of Supreme Court of India, ragging is an offense and it punishable with one-year of imprisonment. In order to create a safe and friendly environment to all the students in the campus, Institution emphasis on creating awareness amongst students and monitoring to avoid such mishaps.

2. SCOPE

The Anti-Ragging Policy will clearly inform and educate all students in the college about the statutory provisions and the merits of the policy. A ragging free campus would assure students and their parents a safe environment.

3. DEFINATION OF ACT OF RAGGING

“The abuse, humiliation, or harassment of new entrants or junior students by the senior students, whether by word spoken, or written (letter text-SMS and e-mails) or by an act, which has the effect of teasing, treating or handling with redeness. Further the ragging also means exploiting the students from completing academic tasks and financial extortion, act of physical abuse, including all its variants-sexual abuse, homosexual assaults, and stripping, forcing abscent and lewd acts, gestures, causing bodily harm or any other danger to health of a person. Any act that prevents disrupts or disturbs the regular academic activity of other students.”

Roles and Responsibilities of Anti Ragging Committee

- a. TO ensure compliance with the provision of UGC regulation 2009 at the institute level.
- b. To initiate preventive measures to make a ragging free campus.
- c. To monitor and oversee the performance of anti-ragging squad in prevention of ragging.
- d. If any ragging cases are reported, the committee shall hear from every individual involved in the case and initiate the proper action.
- e. Conduct systematic and unbiased inquiry of every reported ragging incident using all possible evidences including CCTV footages.
- f. Prepare and submit a complete report including their remarks about the incident for further action to the Head of Anti-Ragging Committee.
- g. Impose penalty to the indulger based on the recommendation of the committee in its report on gravity of the incident.

5. COMPOSITION OF ANTI-RAGGING SQUAD

The structure of anti-ragging squad shall be;

Roles and Responsibilities of anti-ragging squad

- a. To make surprise raids on class room and other places vulnerable to incidents of ragging.
- b. To conduct on the spot enquiry of any suspected incident of ragging.
- c. If any ragging incidents are found, the same shall be reported to the anti-ragging committee for further enquiry.

6. PUNISHMENT RENDERED FOR ACT OF RAGGING

Depending upon the nature and gravity of the offense as established by the anti-ragging committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- a. Suspension from classes and academic privileges.
- b. Withholding/withdrawing scholarship/fellowship and other benefits.
- c. Forfeiting campus placement opportunities/recommendations.
- d. Debarring from appearing in any test/examination or other evaluation processes.

- e. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- f. Cancellation of admission.
- g. Rustication from the institution.
- h. Imposing penalty in the form of fine.
- i. First information Report(FIR) will be filed with the local police authorities, on the direction of the Anti-Ragging committee.

7. PREVENTIVE MEASURES TO MAKE RAGGING FREE CAMPUS

- a. Display of posters in the vulnerable areas of campus, Canteen, Library etc. showcasing anti-ragging laws and ragging consequences along with the helpline number.
- b. Conduct awareness programs to students on Ragging consequences and Anti-ragging laws delivered by lawyers, Law enforcement officials (Police), NGO etc.
- c. Enforcing strict anti-ragging laws in the campus through vigilance by Anti-Ragging Squad constituting of senior faculty members.
- d. The Anti-ragging Squad visits the canteen, parking areas, Library etc. to ensure avoidance of any untoward ragging incidents.
- e. Promote healthy interaction between senior and junior students through various co-curricular and extra-curricular activities.
- f. Usage of CCTV footage to identify the miscreants.
- g. To extend counseling facility for the student indulgers in ragging.
